# Smart Rebate Update

Originally started in 2007 through a DWR Grant for a One-Stop Rebate Program, this program provides a turn-key rebate program for small to medium agencies and matching rebate funds from DWR.



California Urban Water Conservation Council (CUWCC) contracts with a consultant to process applications, manages the contract, funding, provides assistance to participating agencies, site inspections, and marketing materials. The contractor also provides customer service through a hotline to help your customers with the rebate application, determine qualifying devices, amount of rebates, etc.
