Why CII Metrics are Important

- CII makes up 30% of utility water sales in U.S.
- Less than 20% of utilities have CII efficiency programs




Figure 1: U.S. Water Public-Supply Withdrawals 2010




Figure 2. Prevalence of Utility

Working with the CII Sector

- Current challenges:
 - Staff availability and budgets
 - Customer type and water use
 - Inconsistent Categorization
 - Managing and collecting CII water use data (e.g., single water meter serving multiple customers with varied uses)
- Progress in the energy industry:
 - Department of Energy's Building Performance Database¹ (BPD)
 - U.S. Energy Information Administration's Commercial Buildings Energy Consumption Survey² (CBECS)
 - U.S. EPA Portfolio Manager


WRF 4619 Research Objectives

- Implement a defined process for evaluating CII water use
- Develop rate-of-use metrics
 - Adapted from WRF 4375 (Methodology for Evaluating Water Use in the CII Sectors)
- Estimate water use metrics and set benchmarks for selected CII categories.
- To develop a CII water use metrics database that can be integrated with an existing resource (like the EPA Portfolio Manager).
- Provide guidance for water utilities on how to use/implement CII benchmarks.



Utility User's Guide

<u>Intended to help utility staff understand:</u>

- 1) How to apply research to their intended outcomes.
- 2) How data availability, data accuracy, goals, and resources drive which category (below) they are in.





Analyze & Engage

The water provider is largely interested in understanding CII customers water usage and working with their top users but may not have the intent, resources, or political support for further refining CII water use metrics.



Identify Metrics & Set Targets

The water provider wants to use, compare, or establish comparative metrics for CII water users and set targeted goals as an outreach tool but does not intend to enforce compliance.



Track Compliance & Set Rates

The water provider wants to establish metrics and benchmarks for CII customers to meet restrictive water reduction goals and/or set benchmark-based rates which it will enforce.

- Draft deliverables to WRF in Spring 2018; publication by summer/fall
- Project outcomes include
 - Research report
 - Rate of use metrics
 - Research findings
 - Best practices for data collection and processing

 - Insight from participating utilities to balance desired outcomes and available resources
